1. The Wildlife Research and Training Institute (WRTI) is a Corporate Body in the State Department for Wildlife, Ministry of Tourism and Wildlife. It is established under Section 50 of the Wildlife Conservation and Management Act No. 47 of 2013, and operationalized through Gazette Notice No. of 17th July, 2020. pursuant to Section 60(1) of the Wildlife Conservation and Management Act No. 47 of 2013 that provides for the establishment of a comprehensive wildlife database, the Institute seeks to engage the services of a qualified firm to provide consultancy services for development of a comprehensive wildlife database.
2. The Institute now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria on required qualifications and experience of the firm are:
 - i. Experience in the assignment, including technical and managerial capability of the firm.
 - ii. Number of years in business working on the area of the assignment.
 - iii. Reference to at least three assignments of similar nature and size carried out in the last (5) years. Include persons or institutions and contact addresses (phone, email) who can be contacted on the same.
3. The attention of interested Consultants is drawn to the following provisions that will be highlighted in the Request for Proposals to be issued to shortlisted firms.
 - a. The Consultant will be expected to have no conflict of interest with other assignments or its own corporate interests and act without any consideration for future work.
 - b. The consultant has no personal or business relationship with the Procuring Entity's senior management or professional staff.
 - c. A firm or an individual in the firm has not been sanctioned by the Public Procurement Regulatory Institute or is under a suspension or debarment imposed by any other entity of the Government of Kenya, or any international organization.
 - d. Government-owned enterprises or institutions of Kenya Government, officials and civil servants and employees of public institutions may not be eligible.
4. Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
5. A Consultant will be selected in accordance with the method set out in the Public Procurement and Asset Disposal Act, 2015 and Regulations 2020

SECTION 2.

TERMS OF REFERENCE

2.1 INTRODUCTION

The Wildlife Research and Training Institute (WRTI) is a Corporate Body in the State Department for Wildlife, Ministry of Tourism and Wildlife. It is established under Section 50 of the Wildlife Conservation and Management Act No. 47 of 2013, and operationalized through Gazette Notice No. of 17th July, 2020. pursuant to Section 60(1) of the Wildlife Conservation and Management Act No. 47 of 2013 that provides for the establishment of a comprehensive wildlife database.

2.2 The Objective

The objective of the Expression of Interest (EOI) is for WRTI to evaluate and shortlist the best competing firms to develop a comprehensive wildlife database.

2.3 Scope of Work

The scope of the work will be but not limited to:

1. Designing a comprehensive wildlife database;
2. Designing a robust management system that is secure and has intuitive data visualization dashboards with customizable reporting, seamless integration, scalable, web-based applications, accessible across most devices, has versatile archival and retrieval capabilities, and smart organizational characteristics that allow data normalization to detect duplicates and redundancy;
3. Recommending suitable hardware and software options to support the system;
4. Recommending suitable access rights and user management systems;
5. Recommending business continuity and data recovery plans; and
6. Proposing a suitable method for consolidation of existing wildlife data that is in different formats and sizes for uploading into the database.

In providing **services for development of a comprehensive wildlife database to WRTI**, the following shall apply: The interested consultant must be: A company registered in Kenya that:

- a. Understands the wildlife sector
- b. A minimum of five (5) years relevant experience in database development and management;
- c. Demonstrate capacity in web-based applications; and
- d. Proficiency in scripting languages for automating routine database tasks and maintenance.

2.4 EXPRESSION OF INTEREST REQUIREMENTS

Interested bidders shall be required to meet the following requirements:

- a. Submit the legal status of the organization in the form of a Certificate of Incorporation/Registration
- b. Submit Proof of Current Tax Compliance issued by the Kenya Revenue Authority
- c. Provide evidence of experience in providing services of similar nature, complexity, and magnitude.
- d. Demonstrate ability to meet all requirements as defined in the scope of work provided in the detailed Terms of Reference.
- e. The interested firms may be required to illustrate the platform's ability to meet the institute's requirements by way of a product demonstration at the bidder's cost.
- f. Give an outline proposal and operational model of the platform including typical components under the proposed database.
- g. Provide information on possible timelines for implementing the solution by submitting a comprehensive project plan.
- h. Define the infrastructure required to support the implementation, rollout and operate the proposed solution.
- i. Detail your support model (s).
- j. Detail your Licensing model (s)
- k. EOI for each solution should be restricted to a Capability Statement of no more than fifteen

(15) A4 pages.

The attention of interested firms is drawn to the following provisions that will be highlighted in the Request for Proposals to be issued to shortlisted firms;

- l. The firm will be expected to have no conflict of interest with other assignments or its own corporate interests and act without any consideration for future work.
- m. The firm has no personal or business relationship with the Procuring Entity's senior management or professional staff.
- n. A firm or an individual in the firm has not been sanctioned by the Public Procurement Regulatory Institute or is under a suspension or a debarment imposed by any other entity of the Government of Kenya, or any international organization.

2.5 BIDDING PROCESS

This Expression of interest will result in short listing of interested firms who will be invited to submit detail technical and financial bids. Eligibility to participate in the bid process will be determined on the basis of submission of the minimum required documents stated in this Expression of Interest. Upon the deadline for submission of responses, evaluation process will be conducted to determine responsive proposals as per the evaluation criteria provided in the Expression of Interest document. The consultants who participate will be notified of the outcome of the evaluation.

vii) APPENDIX 1 - FRAUD AND CORRUPTION

(Appendix 1 shall not be modified)

1. Purpose

1.1 The Government of Kenya's Anti-Corruption and Economic Crime laws and their sanction's policies and procedures, Public Procurement and Asset Disposal Act (*no.33 of 2015*) and its Regulation, and any other Kenya's Acts or Regulations related to Fraud and Corruption, and similar offences, shall apply with respect to Public Procurement Processes and Contracts that are governed by the laws of Kenya.

2. Requirements

2.1 The Government of Kenya requires that all parties including Procuring Entities, Tenderers, (applicants/proposers), Consultants, Contractors and Suppliers; any Sub-contractors, Sub-consultants, Service providers or Suppliers; any Agents (whether declared or not); and any of their Personnel, involved and engaged in procurement under Kenya's Laws and Regulation, observe the highest standard of ethics during the procurement process, selection and contract execution of all contracts, and refrain from Fraud and Corruption and fully comply with Kenya's laws and Regulations as per paragraphs 1.1 above.

2.2 Kenya's public procurement and asset disposal act (*no. 33 of 2015*) under Section 66 describes rules to be followed and actions to be taken in dealing with Corrupt, Coercive, Obstructive, Collusive or Fraudulent practices, and Conflicts of Interest in procurement including consequences for offences committed. A few of the provisions noted below highlight Kenya's policy of no tolerance for such practices and behavior:

- 1) A person to whom this Act applies shall not be involved in any corrupt, coercive, obstructive, collusive or fraudulent practice; or conflicts of interest in any procurement or as set disposal proceeding;
- 2) A person referred to under subsection (1) who contravenes the provisions of that sub-section commits an offence;
- 3) Without limiting the generality of the subsection (1) and (2), the person shall be: -
 - a) disqualified from entering into a contract for a procurement or asset disposal proceeding; or
 - b) if a contract has already been entered into with the person, the contract shall be voidable;
- 4) The voiding of a contract by the procuring entity under subsection (7) does not limit any legal remedy the procuring entity may have;
- 5) An employee or agent of the procuring entity or a member of the Board or committee of the procuring entity who has a conflict of interest with respect to a procurement: -
 - a) Shall not take part in the procurement proceedings;
 - b) shall not, after a procurement contract has been entered in to, take part in any decision relating to the procurement or contract; and
 - c) shall not be a subcontractor or for the tender to whom was awarded contract, or a member of the group of tenderers to whom the contract was awarded, but the subcontractor appointed shall meet all the requirements of this Act.
- 6) An employee, agent or member described in subsection (1) who refrains from doing anything prohibited under that subsection, but for that subsection, would have been within his or her duties shall disclose the conflict of interest to the procuring entity;
- 7) If a person contravenes subsection (1) with respect to a conflict of interest described in subsection (5)(a) and the contract is awarded to the person or his relative or to another person

in whom one of them had a direct or indirect pecuniary interest, the contract shall be terminated and all costs incurred by the public entity shall be made good by the awarding officer. Etc.

3. In compliance with Kenya's laws, regulations and policies mentioned above, the Procuring Entity:

- a) Defines broadly, for the purposes of the above provisions, the terms set forth below as follows:
 - i) "corrupt practice" is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
 - ii) "fraudulent practice" is any act or omission, including misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain financial or other benefit or to avoid an obligation;
 - iii) "collusive practice" is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party; "coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
 - iv) "obstructive practice" is:
 - Deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede investigation by Public Procurement Regulatory Institute (PPRA) or any other appropriate Institute appointed by Government of Kenya into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - acts intended to materially impede the exercise of the PPRA's or the appointed authority's inspection and audit rights provided for under paragraph 2.3 e. below.
- b) Defines more specifically, in accordance with the above procurement Act provisions set forth for fraudulent and collusive practices as follows:

"fraudulent practice" includes a misrepresentation of fact in order to influence a procurement or disposal process or the exercise of a contract to the detriment of the procuring entity or the tenderer or the contractor, and includes collusive practices amongst tenderers prior to or after tender submission designed to establish tender prices at artificial non-competitive levels and to deprive the procuring entity of the benefits of free and open competition.

- c) Rejects a proposal for award¹ of a contract if PPRA determines that the firm or individual recommended for award, any of its personnel, or its agents, or its sub-consultants, sub-contractors, service providers, suppliers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- d) Pursuant to the Kenya's above stated Acts and Regulations, may recommend to appropriate Institute(s) for sanctioning and debarment of a firm or individual, as applicable under the Acts and Regulations;
- e) Requires that a clause be included in Tender documents and Request for Proposal documents requiring (i) Tenderers (applicants/proposers), Consultants, Contractors, and Suppliers, and their Sub-contractors, Sub-consultants, Service providers, Suppliers, Agents personnel, permit the PPRA or any other appropriate Institute appointed by Government of Kenya to inspect² all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them audited by auditors appointed by the PPRA or any other appropriate Institute appointed by Government of Kenya; and

- f) Pursuant to Section 62 of the above Act, requires Applicants/Tenderers to submit along with their Applications/Tenders/Proposals a “Self-Declaration Form” as included in the procurement document declaring that they and all parties involved in the procurement process and contract execution have not engaged/will not engage in any corrupt or fraudulent practices.

¹For the avoidance of doubt, a party's in eligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and tendering, either directly or as a nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

² Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact-finding activities undertaken by the Investigating Institute or persons appointed by the Procuring Entity to address specific matters related to investigations/audits, such as evaluating the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. Such activity includes but is not limited to: accessing and examining a firm's or individual's financial records and information, and making copies thereof as relevant; accessing and examining any other documents, data and information (whether in hard copy or electronic format) deemed relevant for the investigation/audit, and making copies thereof as relevant; interviewing staff and other relevant individuals; performing physical inspections and site visits; and obtaining third party verification of information.
